BLUE RECRUITS TERMS AND CONDITIONS

- 1. This referral program is operated by Melbourne Victory Limited ACN 111 441 868 trading as the Melbourne Victory Football Club (**Melbourne Victory, we** or **us**).
- 2. Referring a member/s pursuant to these Terms and Conditions is deemed acceptance of these Terms and Conditions.
- 3. Eligible New Members are members who:
 - a) purchase an "access" Membership (being a membership that gives the member the right to access or purchase tickets for Melbourne Victory home matches); and
 - b) were not Melbourne Victory members at any time during the 2021/22, 2022/23 or 2023/24 seasons,

(New Member).

- 4. Current Members under 18 years old must have parental/guardian approval to take part in this Referral Program and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by Melbourne Victory to enter into a further agreement as evidence of consent to the minor entering this Referral Program (or collecting or accepting any reward the subject of this Referral Program).
- 5. This Referral Program commenced on 12 August 2024 and closes at midnight on 3 March 2025 (**Referral Period**). Any referrals made outside of the Referral Period will not count as part of this Referral Program.
- 6. Employees (and their immediate families) of Melbourne Victory and agencies associated with the promotion are ineligible to participate. Receiving a reward

- 11. All eligible Current Members will be notified via email of their reward, including details of how they are to receive or access their reward.
- 12. The rewards in the above rewards table are awarded to the eligible Current Member cumulatively rather than resetting after every reward.

- 18. If an eligible Current Member is unable to attend the match (including due to State or Federal government restrictions) at the time chosen by the member, Melbourne Victory may, but is under no obligation to, provide the member with an alternative reward, as determined by Melbourne Victory.

Signed 2024/25 Jersey (Home or Away)

- 22. Melbourne Victory will endeavour to have the 2024/25 squad signed jersey signed by all members of the Melbourne Victory A-League Men's squad, however makes no guarantee that all or any particular member/s will sign the 2024/25 signed jersey.
- 23. The 2024/25 squad signed jersey will be sent out via post to the postal address Melbourne Victory currently has on file for the relevant Current Member. It is the member's responsibility to notify Melbourne Victory regarding any changes to their personal details, including postal address.
- 24. Whether the 2024/25 squad signed jersey is the Home or Away jersey, is dependent on the stock of signed jerseys at that time. You may receive a call to choose between the two if there is adequate stock.

Inner Sanctum Experience

- 25. The Inner Sanctum Experience will be held at a time and location determined by Melbourne Victory.
- 26. Melbourne Victory is not responsible for any travel costs, or other costs, which an eligible Current Member may incur to attend the Inner Sanctum Experience.
- 27. If an eligible Current Member is unable to attend the Inner Sanctum Experience (including due to State or Federal government restrictions) at the time and location determined by Melbourne Victory, Melbourne Victory may, but is under no obligation to, provide the member with an alternative reward, as determined by Melbourne Victory.
- 28. If the Inner Sanctum Experience cannot be held due to reasons outside the control of Melbourne Victory, such as due to State or Federal government restrictions, Melbourne Victory may postpone or cancel the Inner Sanctum Experience.
- 29. If Melbourne Victory postpones or cancel the Inner Sanctum Experience, Melbourne Victory may, but is under no obligation to, choose to provide the impacted members with an alternative reward, as determined by Melbourne Victory.

'Third Most New Members Referred' determination and the Turkish Airlines double pass reward.

- 37. If there is an impact to the season which results in members and supporters being unable to attend matches, Melbourne Victory may, but is under no obligation to, choose to provide the impacted members with an alternative reward, as determined by Melbourne Victory.

'Second Most New Members Referred' determination and the Victory Medal 2025 reward.

- 38. At the conclusion of the Referral Period, Melbourne Victory will tally all referrals to determine which Current Member made the second most referrals during the Referral Period.

'Most New Members Referred' determination and the Corporate Suite reward

44. At the conclusion of the Referral Period, Melbourne Victory will tally all referrals to determine which Current Member made the most referrals during the Referral Period.

- 45. If there is only one Current Member eligible to the Corporate Site reward, that member and 11 guests of that member's choosing will be entitled to attend the Corporate Suite on a date to be determined by Melbourne Victory.
- 46. If there is a tie in relation to the Current Member with the most referrals, each of those Current Members will be entitled to attend the Corporate Suite together on the date to be determined by Melbourne Victory, and any remaining places in the Corporate Suite reward will be allocated to each of the winners' guests equally. - 51. If there is a dispute concerning the conduct of this Referral Program or in respect to claiming a reward, Melbourne Victory will consider the member's grievances however reserves the right to resolve the dispute in the manner it determines most appropriate, acting reasonably.
- 52. Current Members who accept rewards pursuant to this Referral Program consent to Melbourne Victory using their name, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this Referral Program (including any outcome), and Melbourne Victory.
- 53. If this Referral Program is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of Melbourne Victory, Melbourne Victory reserves the right, to the fullest extent permitted by law, to modify, suspend, terminate or cancel this Referral Program as appropriate.
- 54. Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act (Cth) or similar consumer protection laws in the States and Territories of Australia (**Non-Excludable Guarantees**). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, Melbourne Victory excludes all liability for any personal injury; or any loss or damage (including

loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of this Referral Program and the use of any rewards.

Personal Information

55. The information Current Members and New Members provide to Melbourne Victory will be collected, used and disclosed in accordance with the Melbourne Victory's privacy policy, available here (https://gomvfc.com.au/privacy-policy). This includes the provision of the Current Members' and New Members' personal information to sponsors and partners of the Melbourne Victory (and Australian Professional Leagues Company Pty Ltd ACN 646 799 199 in its capacity as trustee for the Australian Professional Leagues Trust ABN 95 869 867 692).

Third Party Terms

56. If any terms and conditions are imposed by a third party on a Current Member's ability to use some or all of the reward (by way of example, terms of use imposed by O'Brien's Group in relation to the use of the food and beverage voucher or terms and conditions of attending the Corporate Suite) (**Third Party Provider**) then the member must comply with those additional terms (which may include a requirement to demonstrate appropriate standards of behaviour while using the reward) or the member will forfeit the reward (and the ability to continue to use and enjoy the reward) immediately on notice from the relevant Third Party Provider, or Melbourne Victory (as applicable).
