# Terms and Conditions

# 2022/23 Golden Ticket Promotion (the Competition)

# **Entry Details:**

- This Competition is open to Victorian residents only
- You must be 18 years of age or older on 15 July 2022 to enter this Competition.
- Promotion commences on 15 July, 2022 at 9:00am (AEST) and ends on 25 August, 2022 (AEST) at 5:00pm (Promotional Period).
- To be eligible for the Competition an individual must hold (and not cease to hold) an eligible Melbourne Victory membership.
- Eligible entrants go into the draw to win an Ultimate VIP Season Prize (refer to item 10 for prize details) (Prize).
- There will be five (5) winners randomly selected at the end of the Promotional Period, totalling five (5) Prize winners.
- Winners will be notified by receiving a physical membership card with the designation "Golden Ticket" in their 2022/23 membership pack issued by the Promoter.

## Full Terms and Conditions of Entry:

- 1. The "Entry Details" and any other information provided on how to enter the Competition form part of these Conditions of Entry. Your entry into the Competition is deemed acceptance of these Conditions of Entry.
- 2. The promoter of the Competition is Melbourne Victory Limited ABN 62 111 441 868 of Entrance E, AAMI Park, 60 Olympic Boulevard, Melbourne VIC 3000.
- 3. By entering this Competition, you agree to hold harmless the Promoter in respect of the general running and management of the Competition and the Promoter will not be liable for any claim, loss or damage in this respect.
- 4. An eligible Melbourne Victory Membership is any membership paid for (including as part of an auto-renewal and/or instalment payment plan) including:

  - b. All eligible entrants will be placed in a random draw to win one of the five Prizes on offer, which will be announced as contemplated in the entry details above and item 6 below.
- 6. Five winners will be selected at the end of the Promotional Period totalling five (5) Prize winners. The drawing of the winners will be completed by the Melbourne Victory Football Club at Entrance E, AAMI Park, 60 Olympic Boulevard, Melbourne VIC 3000 by automated random selection on Friday, August 26, 2022 at 12.00pm (AEST).
- 7. Each winner will receive a physical membership card with the designation "Golden Ticket" in their membership packs for 2022/23 as confirmation of winning a Prize. If the membership pack does not arrive to the designated address, winners will be notified by telephone and/or by email on Friday, 21 October 2022 and the winners' names will be published online at www.melbournevictory.com.au on the same day.
- 8. If any winner is untraceable within five (5) business days of the Promoter having made reasonable efforts to locate and contact the winner, or if a winning entry is deemed invalid in accordance with these terms and conditions, the Promoter shall conduct a second chance draw in order to select a new winner. The second chance draw will be open to all eligible entrants who entered the first drawing before the end of the Competition Period and who were not selected as the original winner. The second chance draw shall take place on 24 October, 2022 at 12.00pm (AEST) at Entrance E, AAMI Park, 60 Olympic Boulevard, Melbourne VIC 3000. The winner of the second chance draw will be drawn at this time by automated random selection. The winner of the second chance draw shall be notified by telephone and/or email and the winner's name will be published online at www.melbournevictory.com.au on 28 October, 2022.
